NO OBJECTION CERTIFICATE

The UT Administration of Daman & Diu has no objection to the affiliation of **Vaatsalya School, Kakrakhadi, Boriya Talav-Lodha Faliya Road, Magarwada, Moti Daman** with the Central Board of Secondary Education, New Delhi, subject to the following conditions:

- 1) The Administration will bear no financial liabilities to run Vaatsalya School, Moti Daman
- 2) If the school will be closed or will be running in loss then the financial liabilities or any other liability shall be that of the trust and the Government will not be liable in any way.
- 3) The Government will not bear any financial or administrative responsibility of the proposed school. The state government will not be responsible if the school/institution breached of any rules/norms or regulations laid down by above said board.
- 4) No capitation fee or voluntary donation for getting the admission in the school or for any other purpose should be charged / collected in the name of the school as per Rule No.11 of CBSE Affiliation Bye-laws
- 5) Admission to the school is opened to all without any discrimination based on religion, caste, race, sex, place of birth, region or any of them as per Rule 37(v) of Goa, Daman & Diu School Education Rules 1986.
- 6) The school does not involve any unhealthy competition with any existing school of the same category in the neighbourhood (Rule No 37(xx))
- 7) The education imparted in the school is satisfactory in all respects and the teaching staff should be qualified as per the Recruitment Rules in force of UT Administration and CBSE norms.
- 8) Appointment of entire staff of institution should be made calling names from Employment Exchange, Daman & Diu alongwith open advertisement.
- 9) Recruitment/Promotion of employees in school shall be made on the recommendation of the Selection/Promotion Committee. The Director of Education or his/her nominated subordinate officer should be the member of the Selection/Promotion Committee as per Rule No.74 of Goa, Daman & Diu School Education Rules 1986.
- 10) An adequate well furnished building with standard size class rooms may be provided to accommodate existing and proposed number of divisions.
- 11) Physical facilities as per Rule 38 of Goa, Daman & Diu School Education Rules 1986 should be provided.
- 12) The School shall maintain the standards and norms of the school as specified in section 19 of the Right to Education Act.
- 13) Management has to observe the provisions of Act and Rules of CBSE, Goa Daman & Diu School Education Act 1984 & Rules 1986, Right to Education Act 2009.
- 14) The School shall follow the instructions and direction issued by the Administration (Directorate of Education) from time to time.
- 15) The school shall allow unhindered inspection of the school by the officers or Administration/ Directorate of Education as and when required within the normal school hours.
- 16) The N.O.C is subject to their satisfactory functioning according to the Government norms.
- 17) The Administration will have the right to withdraw the N.O.C if it is not satisfied with them on any account.
