CERTIFICATE OF RECOGNITION

This is to certify that Vaatsalya School, Kakrakhadi, Boriya Talav – Lodha Faliya Road, Magarwada, Moti Daman is a recognized private school under Education Department, UT administration of Dadra & Nagar Haveli and Daman & Diu. The school is recognized under section 18 of Right of Children to Free and Compulsory Education Act-2009 and under Rule 36 & 37 of Goa, Daman & Diu School Education Rules, 1986 to run the classes from I to XII. The school runs by a society namely "Vaatsalya Sarvajanik Trust", Rajpipala.

The above recognition is subject to the following conditions: -

1. The school shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 and the Right of Children to Free and Compulsory Education Rules, 2010.
2. The school shall admit in class I, to the extent of 25% of the strength of that class, children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion.
3. The school shall follow the instructions and direction issued by the UT Administration (Directorate of Education) from time to time and such directions under the Dadra & Nagar Haveli and Daman & Diu School Education Act, 1984 and Goa, Daman & Diu School Education Rules, 1986 as amended from time to time shall be binding upon them.
4. The school shall be affiliated with any recognized Board as per section (8) of Dadra & Nagar Haveli and Daman & Diu School Education Act, 1984 and follow the syllabus prescribed by the said Board.
5. The school shall not open any new class without permission from the department.
6. The education imparted in the school should be satisfactory in all aspects and the teaching staff should be qualified as per the Recruitment Rules in force of UT Administration.
7. The school shall allow unhindered inspection of the school by the officers or Administration/ Directorate of Education as and when required within the normal school hours.
8. The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
9. The school shall not deny admission to any child for lack of age proof, if such admission is sought subsequent to the extended period provided prescribed for admission and on the ground of religion, caste or race, place of birth or any of them.
10. The school shall ensure:
 - a. No child admitted shall be held back in any class or expelled from school till the completion of elementary education/in a school;
 - b. No child shall be subjected to physical punishment or mental harassment;
 - c. No child is required to pass any board examination till the completion of elementary education;
 - d. Every child completing elementary education shall be awarded a certificate as laid down under Rule 23;
 - e. Inclusion of Students with disabilities/special needs as per provision of the Act;

- f. The teachers are recruited with minimum qualifications as laid under section 23(1) of the RTE Act.
- g. The teacher performs its duties specified under section 24(1) of the RTE Act.
11. The school shall enroll students proportionate to the facilities available in the school as prescribed in the section 19 of the RTE Act.
12. The school shall maintain the standards and norms of the school as specified in section 19 of the RTE Act.
13. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
14. The school buildings or other structures or the grounds are used only for the purposes education and skill development.
15. The school is not run for profit to any individual, group or association of individuals or any other persons;
16. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared as per rules. A copy each of the Statements of Accounts should be sent to the DEO every year.
17. The school furnishes such reports and information as may be required by the Director of Education/District Education Officer from time to time and complies with such instructions of the State Government/ Local Authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school;
18. Recruitment/Promotion of employees in school shall be made on the recommendation of the Selection/Promotion Committee.
19. Renewal of Registration of Society if any be ensured.
20. The management shall follow the directions issued by the Government/Department from time to time keeping in view of the safety and security of the children and the overall administration of the school.
21. The certificate of recognition issued by the department shall be subject to the fulfillment of deficiencies if any pointed out by the department at any stage /time.
22. The management shall rectify the deficiencies pointed out in infrastructure or administration by the authorities.
23. The recognition shall be withdrawn if the contravention of the provisions of the Acts, Rules or the conditions of the recognition are found and proved.
24. The school management shall have to full responsibility if any court cases arise this regard. The management is not entitled to seek affiliation to other Board without obtaining NOC from the Directorate of Education, Daman.
